





According to the International Federation of American Football, 2.4 million kids under 17 are playing organised flag football in the U.S., while millions more participate in flag globally.





Notes to the financial statements

For the year ended 31 December 2024

This financial report is a special purpose financial report prepared to satisfy the financial reporting requirements of the Associations Incorporation Act 1981 (Qld).

In the opinion of those charged with governance, the Association is not a reporting entity since there are unlikely to be financial statement users who cannot command preparing reports tailored to satisfy all their information needs.

The financial report has been prepared on an accruals basis, using historical costs. Accordingly, it does not consider changing money values or, except where expressly stated, current valuations of non-current assets.

The following material accounting policies, consistent with the previous period unless otherwise stated, have been adopted in preparing this financial report.

Income tax:

The association is exempt from income tax by Section 50 of the Income Tax Assessment Act 1997. Accordingly, no liability is recognised.

Goods and Services Tax (GST):

The Association is registered for GST; accordingly, all revenues, expenses and assets are recognised, excluding the amount of GST.

Revenue:

As is typical for organisations of this size and type, it is not practicable for the Association to maintain effective internal control over income until their initial entry into the accounting records. Accordingly, the financial report about income is limited to the amounts banked and recorded in Xero.

Review Conclusion

Report on the Financial Report

The financial report comprises the income statement, balance sheet, notes to the financial statements, and the members of the committee declaration for **Gridiron Queensland Inc – IA13129** (the Association) for the year ended **31 December 2024**. The members of the Committee of the Association are responsible for the preparation and true and fair presentation of the financial report in accordance with the Associations Incorporation Act 1981 (Qld) and regulations. This includes responsibility for maintaining adequate accounting records and internal controls designed to prevent and detect fraud and error and for the accounting policies and accounting estimates inherent in the financial report.


